In the International Business Specialization, learners developed a broad foundational understanding of the scale, scope, and execution of contemporary international businesses. Learners reviewed the differences and challenges of international versus domestic business management. They explored the history, theory, and economics of globalization and the relationships of these to international business. Learners surveyed the implementation of business functions in a global context, including marketing, human resource management, supply chain management, logistics, and foreign currency exchange. Finally, learners examined the methods businesses use to engage in international commerce including exporting, contract entry, and foreign direct investment.
